**1660-02-07-.02 AEDC LAKE.**

- (1) Motorboats shall not exceed idling speed under the Morris Ferry Bridge or more than six (6) miles per hour within one hundred (100) feet of any shoreline or other designated area.
- (2) All boats shall enter or depart loading and docking areas slowly to avoid endangering people boarding or loading boats.
- (3) Boats and skiers shall not pass within one hundred (100) feet of a skin diver's surface marker.
- (4) Boats shall keep a distance of one hundred (100) feet (right or left) when passing another boat.
- (5) Boats and skiers are prohibited in posted areas being used by swimmers, except craft used for life saving purposes.
- (6) Boating is prohibited in all areas officially marked as restricted by AEDC.

**1660-02-07-.04 OLD HICKORY LAKE.**

- (1) Vessels are prohibited in the Old Hickory Beach Swimming Area located on the southwest side of Old Hickory Lake in the cove nearest the dam and delineated by a line of informational buoys.
- (2) Vessels being operated in the cove adjacent to and south of the Old Hickory Beach Swimming Area shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (3) Vessels being operated in the cove adjacent to the Rockland Day Use Area which is located near Old Hickory Dam and Lock in Sumner County and delineated by a line of informational buoys shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (4) Vessels being operated on Old Hickory Lake within the area, as delineated by a line of informational buoys, adjacent to Walton's Ferry Access in Sumner County near River Mile 220.8, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (5) Vessels being operated on Old Hickory Lake in the portion of Shutes Branch known as Langfords Cove, south of the highway bridge and the area adjacent to Shutes Branch Recreation Area, both as delineated by informational buoys, in Wilson County, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (6) Unauthorized vessels are prohibited from entering that designated area adjacent to the DuPont Loading Dock located at River Mile 218.
- (7) Vessels being operated on Old Hickory Lake within the Laguardo Recreation Area in Spencer Creek (River Mile 236) shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
  - (c) Vessels are prohibited in the swimming area.

- (8) Vessels being operated on Old Hickory Lake in the area known as Fetherling Cove located at River Mile 218.5 in Sumner County and delineated by informational buoys shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (9) Vessels being operated on Old Hickory Lake within the area adjacent to the Lock 3 Access in Sumner County near River Mile 218, as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
  - (c) Vessels are prohibited in the swimming area.
- (10) Vessels being operated on Old Hickory Lake within the area adjacent to the Sanders Ferry Park Access in Sumner County near River Mile 222, as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (11) Vessels being operated on Old Hickory Lake within the area adjacent to Creekwood Marina and the Mallard Point Access located in Drakes Creek in Sumner County, as delineated by a line of informational buoys, spanning the entire width of the waterway, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
- (12) Vessels being operated on Old Hickory Lake within the area adjacent to the Stark Knob Access in Sumner County near River Mile 225.5, as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (13) Vessels being operated on Old Hickory Lake within the area adjacent to the Saundersville Access in Sumner County near River Mile 228.2, as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (14) Vessels being operated on Old Hickory Lake within the area adjacent to the Avondale Access in Sumner County near River Mile 229.4, as delineated by a line of informational buoys, shall be operated as follows:

- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (15) Vessels being operated on Old Hickory Lake within the area adjacent to the Cages Bend Campground Access in Sumner County near River Mile 234, as delineated by a line of informational buoys, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (16) Vessels being operated on Old Hickory Lake within the area adjacent to the Station Camp Access located in West Fork Station Camp Creek in Sumner County, as delineated by a line of informational buoys, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (17) Vessels being operated on Old Hickory Lake within the area adjacent to the Bull Creek Access in Sumner County near River Mile 239.6, as delineated by a line of informational buoys, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (18) Vessels being operated on Old Hickory Lake within the area adjacent to the Lone Branch Access located in Cedar Creek in Wilson County, as delineated by a line of informational buoys, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (19) Vessels being operated on Old Hickory Lake within the area adjacent to the Cedar Creek Campground Access located in Cedar Creek in Wilson County, as delineated by a line of informational buoys, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
  - (c) Vessels are prohibited in the swimming area.
- (20) Vessels being operated on Old Hickory Lake within the area adjacent to the Burton Road Access located in Spencer Creek in Wilson County, as delineated by a line of informational buoys, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.

- (21) Vessels being operated on Old Hickory Lake within the area adjacent to Gallatin Marina located in Sumner County, spanning the entire width of the east fork of Station Camp Creek, as delineated by a line of information buoys, shall be operated as follows:
- (a) Motorboats shall operate at a “Slow-No Wake” speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.

**1660-02-07-.05 PERCY PRIEST RESERVOIR.**

- (1) All motorboats being operated within the sites described below shall be operated at a “Slow-No Wake” speed and shall not tow a person on water skis, surfboard or similar devices.
- (a) Site No. 1, Elm Hill Public Use Area located on the west bank of the reservoir approximately River Mile 9.4.
  - (b) Site No. 2, Hermitage Public Use Area located east of Percy Priest Dam at approximately River Mile 6.8, the area known as Hermitage Cove.
  - (c) Site No. 3, Hamilton Creek Public Use Area located on the west bank of the reservoir in Hamilton Creek Cove at approximately River Mile 10.5.
  - (d) Site No. 6, Suggs And Vivrett Creeks, Public Use Area located on the east bank at the head of the Suggs Creek embayment at approximately River Mile 12.5.
  - (e) Site No. 9, Four Corners Public Use Area located on the west bank of the reservoir in the Hurricane Creek embayment at approximately River Mile 18.5.
  - (f) Site No. 16, Fate Sanders Public Use Area located on the east bank of the reservoir at approximately River Mile 29.3.
  - (g) Site No. 13, Poole Knobs Public Use Area located on the west bank of the reservoir in the vicinity of Sinking Creek at approximately River Mile 24.
  - (h) Site No. 20, Fall Creek Public Use Area located on the east bank of the reservoir within the Fall Creek embayment at approximately River Mile 33.1.
  - (i) Site No. 10, Long Hunter State Park located on the east bank of the reservoir at approximately River Mile 20.8.
  - (j) Site No. 11, Elm Hill Public Use Area located on the west bank of the reservoir at approximately River Mile 9.9.
  - (k) Site No. 12, Smith Springs Recreation Area located on the west bank of the reservoir at approximately River Mile 14.

- (l) Site No. 13, Cook Recreation Area located on the east bank of the reservoir at approximately River Mile 11.4.
  - (m) Site No. 14, Seven Points Recreation Area located on the east bank of the reservoir at approximately River Mile 12.
  - (n) Site No. 6, Anderson Road Day Use Area is located on the west bank of the reservoir at approximately River Mile 13.
  - (o) Site No. 26, Hamilton Creek Launch Ramp is located on the west bank of the reservoir at approximately River Mile 10.5.
  - (p) Site No. 11, Fate Sanders Day Use Area is located on the east bank of the reservoir at approximately River Mile 30.5.
  - (q) Site No. 15, Jefferson Springs Day Use Area is located on the west bank of the reservoir at approximately River Mile 36.
  - (r) Site No. 10, Poole Knobbs Day Use Area is located on the west bank of the reservoir River Mile 28.
  - (s) Site No. 13, Stewart Creek Day Use Area is located on the west bank of the reservoir at approximately River Mile 29.5.
  - (t) Site No. 4, Seven Points Campground Launch Ramp is located on the east bank of the reservoir at approximately River Mile 12.
  - (u) Site No. 3, Cook Day Use Area Launch Ramp is located on the east bank of the reservoir at approximately River Mile 8.5.
  - (v) A portion of the area leased by the YMCA lying within a cove located on the left descending bank, east of the Smith Springs Recreation Area, which extends outward in a 300-foot radius, more or less, from the YMCA dock as delineated by a line of buoys.
  - (w) A cove on the left descending bank adjoining the YMCA property at Stones River Mile approximately 5.3.
- (2) All areas listed above are further identified by informational buoys in the water on entering or leaving the areas and by informational signs at launching ramps located within or near the areas.
- (3) Vessels being operated on J. Percy Priest lake within the Hermitage Recreation area, as delineated by a line of informational buoys, in Davidson County, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard or similar devices.
- (4) Vessels are prohibited in the sites described below:
- (a) Cook Recreation Area swimming beaches
  - (b) Anderson Road Recreation Area swimming beach
  - (c) Seven Points Recreation Area swimming beaches

- (d) Poole Knobs Recreation Area swimming beach

The areas listed above are further identified by informational buoys.

- (5) Vessels being operated on Percy Priest Reservoir within the Stewart Creek Fishing Cove at Stones River Mile 14.0 as delineated by a line of informational buoys shall be operated as follows:
- (a) Vessels operate with electric trolling motors and paddles only.
- (b) Area designated as fish-only zone.
- (6) Vessels being operated on Percy Priest Reservoir within the Vivrette Creek Fishing Cove located on the east bank of the reservoir at approximately River Mile 12.5 in Suggs Creek as delineated by a line of informational buoys shall be operated as follows:
- (a) Vessels operated with electric trolling motors and paddles only.
- (b) Area designated as fish-only zone.
- (7) Vessels being operated on Percy Priest Reservoir within the cove known as Party Cove on the left descending bank of the reservoir and west of the Hobson Pike Bridge and within the lease area of the YMCA Camp as delineated by a line of buoys shall be restricted to vessels operating with electric trolling motors and paddles only from May 1 through September 30. From October 1 through April 30, this will be a no-wake zone.

- (1) Vessels being operated on Pickwick Lake within the Winn Springs Cove area, as delineated by a line of informational buoys, near River Mile 214 in Hardin County, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
- (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (2) Vessels being operated within Slate Rock Creek, Sulphur Creek, and Caney Creek, shall be operated as follows:
- (a) Motorboats shall operate at a "Slow-No Wake" speed.
- (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.

**1660-02-07-.07 CENTER HILL LAKE.**

- (1) Vessels being operated on Center Hill Reservoir within the Floating Mill Park Recreation Area as delineated by a line of informational buoys shall be operated, as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
- (2) Vessels being operated on Center Hill Lake within the area adjacent to Sand Beach, Rock Island State Park, as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
- (3) Vessels being operated on Center Hill Lake within the Ragland Bottom, Johnson Chapel, and Hurricane Bridge Recreation Areas, as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
- (4) Vessels being operated on Center Hill Reservoir near Cookeville Boat Dock Marina within the Falling Water River channel spanning the entire waterway, as delineated by a line of information buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
- (5) Vessels being operated on Center Hill Reservoir within the Caney Fork River arm near Sligo Marina, as delineated by a line of informational buoys spanning the entire waterway, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube, or similar devices.
  - (c) This zone is effective from May 15 to September 15 annually.

- (a) All motorboats operating within 150' of boat launching ramps as designated by buoys shall be operated at a "Slow-No Wake" speed, and shall not tow a person on skis, surfboard or similar devices.
- (b) Motorboats are prohibited from operating within areas designated by buoys for swimming.
- (c) Beech Lake, Henderson County-Vessels operating in the first cove north of Beech Lake Dam on the east side of the lake, as delineated by a line of information buoys, shall operate at a "Slow-No Wake" speed.

- (1) All vessels are prohibited from U.S. Forest Service Watauga Point Recreation Swim Area (WRM 40.1L) and U.S. Forest Service Shook Branch Swim Area (WRM 37L) as delineated by line of "No Boating" buoys.
- (2) Vessels being operated on Watauga Reservoir at U.S. Forest Service's Rat Branch Boat Ramp (WRM 37.0L) as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.

- (1) Vessels being operated on Tims Ford Lake within a portion of Hasty Hollow Cove and Tennessee Elk River Development Association's Campground Cove (River Mile 153), as delineated by a line of informational buoys, shall be operated as follows:
  - (a) Motorboats shall operate at a "Slow-No Wake" speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.

(Rule 1660-02-07-.10, continued)

- (2) Vessels being operated within Travis Hollow at River Mile 140 on Tims Ford Reservoir, shall be operated as follows:
  - (a) Motorboats shall operate at a “Slow-No Wake” speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (3) Vessels being operated in an area delineated by signs and/or buoys near the mouth of Rock Creek and Elk River Mile 162 shall be operated as follows:
  - (a) Motorboats shall operate at a “Slow-No Wake” speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices within the “Slow-No Wake” area.
- (4) Vessels are prohibited in the swimming area located in the Dry Creek embayment adjacent to the Highway 50 bridge.
- (5) Vessels being operated on Tims Ford Lake in the Dry Creek section which is located adjacent to State Highway 50 in Franklin County and delineated by informational buoys shall be operated as follows:
  - (a) Motorboats shall operate at a “Slow-No Wake” speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (6) Vessels being operated on Tims Ford Lake in Boiling Fork Creek near the State Highway 130 bridge as delineated by signs and/or buoys shall be operated as follows:
  - (a) Vessels shall operate at a “Slow-No Wake” speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices.
- (7) Vessels being operated in the area delineated by signs and/or buoys at the Tims Ford Reservation access ramp, Elk River Mile 133.6L shall operate as follows:
  - (a) Vessels shall operate at a “Slow-No Wake” speed.
  - (b) Motorboats shall not tow a person on water skis, surfboard, inner tube or similar devices within the “Slow-No Wake” area.

**1660-02-07-.11 SPECIAL AREAS.**

  - (a) The measurement shall be made from the last structure associated with the dock or marina except as noted above.
  - (b) For this rule, a commercial marina is defined as any permanent facility accessible by boat which:
    1. Offers goods or services to the general public in exchange for currency or other consideration,
    2. Has a valid business license, if required, and a Tennessee Tax Identification number,
    3. Is permitted by the U.S. Corps of Engineers, and the Tennessee Valley Authority if applicable, as a commercial boat dock or marina.
- (2) No person shall operate or use any vessel, within the area designated and appropriately marked as a hazardous area, below any dam and/or lock unless each person aboard is wearing a U.S. Coast Guard approved wearable flotation device in accordance with the approval label.
  - (a) This regulation is not intended to affect regulations promulgated by other governmental agencies, federal or state, related to activities that may or may not be conducted within said hazardous area.
- (3) Vessels being operated within 300 yards of the Tennessee Wildlife Resources Agency access ramp on Indian Creek will be operated at a "Slow-No Wake" speed.
- (4) Vessels being operated on Deer Creek located at River Mile 125 on Kentucky Lake shall operate at a "Slow-No Wake" speed within the embayment area.
- (5) Water skiing is prohibited on Great Falls Reservoir in the Rock River Embayment from its mouth upstream to Blanks Bridge.
- (6) Vessels being operated on Crooked Creek located at River Mile 121.5 on Kentucky Lake shall operate at a "Slow-No Wake" speed from the mouth of the Tennessee River to the Crooked Creek embayment.

- (6) Vessels being operated on Cordell Hull Lake in the portion of Flynn's Lick Creek adjacent to Camp Discovery, as delineated by a line of buoys, shall be operated as follows:
